COG Copperhead 31 Federal Com #1H 2RP-96 & 2RP-5034

All,  
We were told by the OCD Environmental Bureau Chief that multiple RP-Number Reports will require a payment for each RP-Number. In the case of this Report on the "COG Copperhead 31 Federal Com #1H 2RP-4796 & 2RP-5034", it would require 2 payments of \$150 (one for each RP-Number).

Generally, The \$150 fee applies to:

1. Initial C-141
2. Remediation Plan or Deferral
3. Closure Report

Each form requires a separate fee if sent in separately. If a Remediation-Closure Report was sent in on the same report, it would only require 1 payment of \$150 instead of 2.

An Initial/Final C-141 Report (would also require only 1 fee if sent as a single document).

If the form is incomplete or denied, the forms will be charged an additional \$150 fee at resubmission.
