Hello Heather,

I have a couple of question regarding Julie #1 **2RP-5569**:

- On Page 2, **3.0 Release Characterization and Remediation Activities**, the report says L2 was excavated to eight feet bgs, and two samples were collected @6 and 8 feet. Did you take samples at sample point L2 @2 and 4 feet?
- On April 29 (April 26 in Table 3, I guess) a total of six samples were collected during site investigation activities for laboratory analysis, but you are reporting lab results for just two samples (L1/B1 8 feet and L1/B1 10 feet). Could you please provide the results for the other four samples?
- **Confirmation Samples:** What does 0-15' means? Were all confirmation samples taken @15 feet on the bottom of the excavation? Could you please provide and explanation? .
- **By rule, the final report must include photographs of the remediated site prior to backfill.** Please, provide pictures of the excavation before backfill.

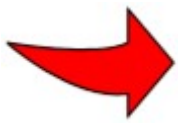
