Question 1: No these are two separate locations. We have two separate spill incidents that we are addressing. This is strictly an aerial (vicinity) map showing the area and the nearest POD.

Question 2: No AH3, AH5, AH6, and AH7 results were at acceptable RL's at 1ft. bgs., so those were not taken to the lab for official analyses. Field results are as follows:

AH-3 @ 2 ft 736 ppm

AH5 @ 3 ft 796 ppm

AH6 @ 3 ft 796 ppm

AH7 @ 3 ft 796 ppm

I hope this helps clarify the soil analyses.

Yes ma'am I am aware that you are missing the remaining pages of the C-141. Devon personnel complete there C-141's in office and are signed by them. So, I too am awaiting the remaining pages.

There is no record of groundwater in this same section as the Snapping 2 State #3 H, so I researched and mapped the nearest POD of reference in the vicinity map.
