## Gentleman,

Today I submitted a variance request for 1 RP-5677. The impacted area has been excavated to a depth of 12 feet. Final bottom and wall samples have been collected representing every 200 square feet. There were a few areas on the bottom that exceed the regulatory requirements. The excavation was stopped at 12 feet due to groundwater being 16 feet below ground surface. The variance request is asking that those area be left in place and the excavation be backfilled with clean imported caliche to a depth of 6 feet below ground surface and installing a 20 mil liner. Apache Corporation would like to start backfilling the release asap due to production and power to multiple wells has been shut in. The PO number associated with the filing is 9J3X5-191015-C-1410. It is OCD's considered opinion, based on current depth of dig out and depth to water reported, that Apache should anticipate setting at least one ground water monitoring well/point and sample groundwater for full suite from Table I, as far as hydrocarbons and chloride.
