Good morning all,

Closure is not approved. Per NMAC 19.15.29.13(D)(1) the upper 4' should "non-waste containing" material regardless of depth to groundwater. All confirmation samples collected a depth shallower than 4' bgs are held to the strictest remediation standard; below 4' the remediation standard is determined by depth to groundwater. This is covered in the "Procedures for Implementation of the Spill Rule" document that NMNRD sent out a few weeks ago. Please let me know if you have any questions or are interpreting the rule differently.
