- On June 21, 2019, during hydraulic fracturing operations in the 2nd Bone Springs formation at the Corral Canyon Federal Com 006H well in Eddy County, New Mexico, underground pressure communication was established with the Pickett Draw Federal #1 well.
- Pressure communication led to flowline failure on Pickett Draw Federal #1 resulting in a release of produced fluid consisting of primarily water.
- Impacts of produced fluid occurred on location and to the pasture to the northwest (approximately 61 feet from pad, 32.150347, -103.991909) and to the northeast (overspray approximately 180 feet from pad, 32.150617, -103.991295).
- The event was addressed quickly, and
- Currently, there is no ongoing unconstrained flow.
