Under the new spill rule a closure report is due for the above release on 5/19/19. COG has submitted a work plan which was approved by the NMOCD on February 18, 2019, however COG is still awaiting approval from the BLM. We can't start remediation activities without BLM approval. COG is requesting a three month extension until August 19, 2019 in order to hopefully obtain BLM approval and conduct remediation activities and prepare a closure report. If we do not obtain BLM approval we may have to request an additional extension. Please let me know if you have any questions.
