XTO is requesting an extension of the current 90 day deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Ross Ranch 6 Federal #001H Battery (2RP-5491). The spill occurred June 2, 2019 and site assessment began June 7, 2019. Further site assessment and remediation work was started August 15, 2019 and is currently ongoing. To provide enough time to fully assess the site and conduct remediation work, XTO requests a 30-day extension of the current deadline until September 30, 2019.
