All,

XTO is requesting an extension to the current deadline of May 24, 2019 for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Corral Canyon Federal #1H Flow Line (RP# 2RP-5201). The release was discovered on January 9, 2019. XTO was unable to initiate site activities until BLM provided site clearance, leading to the initial extension request. A second request was requested to use a drilling rig to collect final characterization samples following initial excavation of impacted soil. Drilling was delayed by work at another site, but began on Sunday, May 19, 2019. Based on progress after one day and initial drilling results, XTO requests an extension of the existing deadline of May 24, 2019 until July 5th, 2019. That schedule will provide enough time to complete drilling activities and submit an appropriate remediation work plan with full delineation.
