Under the new spill rule a closure report is due for the above releases on 7/29/2019. COG submitted a work plan which was approved by the NMOCD on April 30, 2019, however COG is still awaiting approval from the SLO. We can't start remediation activities without SLO approval. COG is requesting a three month extension until October 29, 2019 in order to hopefully obtain SLO approval and conduct remediation activities and prepare a closure report. 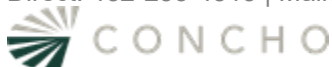
