WPX is requesting an extension of the current deadline of April 14, 2020, for completing a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the RDX Fed Com 28 #009H (2RP-5700). The release was discovered October 17, 2019. The initial inspection conducted on January 2, 2020, deemed that the liner had been compromised. On January 9, 2020, soil samples were collected beneath the liner where four tears had been observed. Remediation work is ongoing and final sampling is planned to begin this week. WPX is requesting an extension in order to complete remediation and the closure report. WPX requests an extension of the current deadline until July 13, 2020.

WPX Energy is requesting an extension of the current deadline of January 15, 2020, for completing a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the RDX Fed Com 28 #009H (2RP-5700), Incident# NRM1932253587. The release was discovered October 17, 2019 inside lined secondary containment. The initial inspection conducted on January 2, 2020, deemed that the liner had been compromised. On January 9, 2020, soil samples were collected beneath the liner where four tears had been observed. Additional time is being requested to review soil laboratory analytical results and determine if additional remediation is warranted. WPX requests an extension of the current deadline until April 14, 2020.
