DeAnn,

The BLM has reviewed your request for deferral due to poly flowlines and access road for safety concerns. Photos are showing the surface of the spill already excavated and the excavation backfilled. I see no reason why we can't move the two lines to the west onto the previously reclaimed area and excavate the high chloride levels at least up to the road. The oilfield works around these conditions all the time. This should be no difference. If the impact continues onto the road then we would approve the deferral at that point. Note: The spill site appears to be on a slight slope, erosion controls should be placed across the slope and seeded with BLM No.3 seed mix. Provide the final closure when this work is complete. Thanks
