Good morning,

WPX is requesting an extension to the current deadline date of August 14, 2020 for release Tucker Draw 9-4 Fed Com 1H, incident # NRM2014052691, to submit a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC. A liner inspection was completed by WPX on May 29, 2020 to address any potential liner issues and none were found. However, on June 7, 2020 a release occurred on the Tucker Draw 9 4 Federal Com #002H separator (NRM2019634169) in the same containment before the closure report could be sent to the State. While replacing the #002H separator, the liner was torn, compromising liner integrity.

WPX requests an extension date of the current deadline until October 4, 2020 to address the lined containment breach and to prepare a closure report to encompass both releases.
