EOG Resources, Inc. respectfully requests an extension for the Characterization/Remediation Plan for the below listed site to Friday, September 10, 2021. The Characterization/Remediation Plan is currently due July 6, 2021, but in order to present a comprehensive plan for NMOCD review, further delineation sampling would need to be completed. The consultant sent a contractor to access the condition of the site today and found that all main roads to the site are either underwater or washed out, leaving the site inaccessible. After confirming with the consultant performing the onsite work, they believe they can have the Characterization/Remediation Plan completed and ready for submittal to NMOCD by Friday, September 10, 2021, if there are no long term closures of the roads.
