I talked to Mike Bratcher about this release. The initial was sent before the Waste Rule went into effect on 5/25/2021. The closure was sent on 7/9/2021, which is after that date. We will go ahead and close this one out. In the future, **all venting/flaring of gas with no liquids touching ground after 5/25/2021 needs to submit an electronic form C-129 to the payment portal. C-141s are no longer accepted for these types of releases.**
