XTO is requesting an extension for the current deadline of November 23, 2021 for submitting a

remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at PLU 25 BD 127H (Incident Number nAPP2125143187). The release was discovered August 25, 2021 and initial site assessment was conducted. Flowback operations have been ongoing and to ensure the safety of all personnel and the environment, non-essential personnel were not permitted on site. This has prevented XTO from completing remediation work. Operational updates will be provided to XTO's environmental group to ensure that work begins as soon as the flowback operations are complete and the Site is cleared. To provide enough time to fully assess the site and conduct remediation work, XTO requests a 90-day extension of this deadline until February 21, 2022.
