We are currently working on the remediation for nAPP2129846784. After working through the BLM for proper approvals and the standard holiday delays, we are in the process of treatment.

Ascent Energy is listed as the "Responsible Party" on the website, but NexGen Water Solutions has accepted the actual responsible party, shown by submitting the C141.
