

3. Pick up 6 3/4 mill, 6 - 3 1/2 D.C. G.I.H. Mill & Clean out well to T.D.
4. Pick up 4 1/2 float shoe G.I.H. 62 jts 4 1/2 csg. Shoe set @ 2792' Tie onto 4 1/2 csg. Pump 300 sx cmt. to surface & tie onto 7" & pump 50 sx cap plug.
5. Pick 3 7/8 bit 6 - 3 1/2 drill collars G.I.H. drill out plug and drill out down to T.D. 3133' C.O.H. lay down tools.
6. Run Production Equipment.
