3. Perforate Atoka formation from 10,548' to 10,640'. Run pkr. Acidize and swab test zone for commercial production. Plugback w/ CIBP and cement if necessary.
4. Perforate Strawn formation from 10,242' and 10,268'. Run pkr. Acidize and swab test zone for commercial production. Plugback w/ CIBP and cement if necessary.
5. Perforate Canyon formation from 9,886' to 9,910'. Run pkr. Acidize and swab test zone for commercial production. Plugback w/ CIBP and cement if necessary.
6. Perforate Wolfcamp formation from 9,222' to 9,244'. Run pkr. Acidize and swab test zone for commercial production.
7. Run 2-3/8" tubing.
8. ND BOP. NU wellhead. RD workover unit. Clean location.
