Additional Comments: Work plan closure for encapsulation trench. The drilling pit contents will be mixed to stiffen the pit contents. An encapsulation trench will be excavated on former drilling pit site and lined with a 12 mil synthetic liner. Drilling pit contents will then be emplaced into the encapsulation trench. A 20 mil. Synthetic liner will then be placed over the pit contents with a min. of a 3' over lap of the underlying trench area. The encapsulation trench will then be backfilled back to grade using a min. of 3' of clean soil and like material. Mud seed shall be applied. A one call & 48 hour notice will be provide to the Oil Conservation Division before pit closure actions began.
