We plan to breakout the pit and mix with surrounding material and cover with 20 mil plastic, then cover with 3' of clean native soil or like material capable of supporting native plant growth. We will contour the pit area to prevent erosion and ponding of rainwater over the site as per Rule 50 of the Pit and Below-Grade Tank Guidelines.
