Tailed in with 100 sx 15:61:11 "C" + 6/10% FL-52A + 6/10% FL-25 + 3% KCL + 5# LCM-1 + 1% BA-10A (yld 1.61, wt 13.2). Cement did not circulate. Calc. top of light cement at 1300'. Tested casing to 1500 psi for 30 min. WOC 42 hrs 15 min. Reduced hole to 6-1/8" and resumed drilling.
