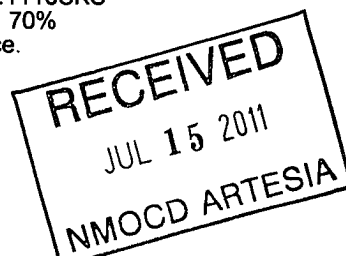

Class C 50/50 Poz + 10% Bentonite, + 0.3% FL-10 + 0.25% R-38 + 5% Salt 14.6ppg 1.54yield 70%
Excess, Tail:105SKS HalCem + 1% CaCl 14.8ppg 1.34 yield 25% Excess. Circulate to surface.
