Describe Cause of Problem and Remedial Action Taken.*

There was a failure of the packing on the wellhead causing a release of crude oil and produced water.

Describe Area Affected and Cleanup Action Taken.* An approximate area of 160' X 30' was affected running from the wellhead running east on the production pad. A vacuum truck was called to recover the standing fluid and a backhoe was called to excavate impacted soil. Impacted soil will be hauled to NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: >100' (approximately 110', Section 28, T19S-R25E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on completion of the NMOCD approved work plan (2/11/2016), Yates Petroleum Corporation requests closure.**
