
Describe Cause of Problem and Remedial Action Taken.\*

The motor burned out on the produced water tank and it overflowed. Wells were shut off and vacuum truck(s) and roustabout crew were called.

Describe Area Affected and Cleanup Action Taken.\*

The area affected was within the unlined, bermed battery (dimensions are unknown at this time). The wells were shut off and problems with the motor were corrected. Vacuum truck removed standing fluid (175 B/PW). Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 20) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted to the OCD. **Depth to Ground Water: < 50' (approximately 35'), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 20. Yates requests closure as all work has been completed as per the previously NMOCD approved work plan.**
