On behalf of Chevron Environmental Management Company (CEMC), Arcadis U.S., Inc. (Arcadis) prepared this Site Status Letter (Letter) for the Amoco Federal 11 Well No. 1, API No. 30-015-22975, located in Eddy County, New Mexico. Rockcliff Operating New Mexico LLC (Rockcliff), the previous owner of this well, was notified by the New Mexico Oil Conservation District (NMOCD) of a violation dated December 7, 2017 during an inspection (iTM1734133661) by NMOCD. No response to this violation has been located. The purpose of this letter is to update the NMOCD; the violation will be addressed and supporting documentation will be provided to the NMOCD.

SITE DESCRIPTION AND BACKGROUND

The Site is located approximately two (2) miles east of Loving, New Mexico. The site is in Unit I, Section 11, Township 23S, Range 28E, Eddy County, New Mexico, on private land.

On December 6, 2017, during a routine inspection (iTM1734133661) conducted by NMOCD. Staining was observed around the well and the tank battery did not have placards or a windsock. A letter of violation was issued to Rockcliff. No response to this violation has been located. Chevron acquired the lease for this well in October 2018 and is currently evaluating this well for ongoing production. Work to address this violation will be coordinated with other maintenance work at this well. A response documenting that the violation has been addressed will be submitted to the NMOCD upon completion of activities.
