3/17/2020 Cleared location. Moved in rig and rigged up. Tubing was parted just below the wellhead. Tagged fish with wireline at 100'. RIH with workstring and spear and caught fish. Worked pipe free and started laying down the tubing that was in the well. SION

3/18/2020 Finished laying down tubing. Set 4 ½" CIBP at 1752'. Circulated MLF and tested casing to 500#. Casing good. Spot 35 sx Class C cement on top of CIBP. POOH and perforated casing at 485'. Pressured up on perfs to 500# and held with no drop. Bumped the pressure up to 700# and held. Bled off at the truck and pressured up again to 700#. Repeated the process with same result. RIH with tubing to 539' and circulated cement to surface with 40 sx. Laid down remaining pipe and rigged down.

3/19/2020 Dug out and cut off wellhead. Cement had fallen considerably inside the 4 ½" casing and there was no cement or fluid inside the annulus between the 4 ½" and 8 5/8" casing. Filled up the 4 ½" casing with 15 sx and the annulus with 40 sx. Cement remained at surface in both strings of casing. Installed marker, removed anchors, cleaned the pit and cleared the location.
