Plugging Report
Artesia Metex Unit #64

3/23/2020 Clear location and located anchors. Moved in rig and spotted over the hole.

3/24/2020 Rigged up and unseated pump. Laid down 83 7/8" rods. Installed BOP and laid down 65 joints of 2 7/8" tubing. Moved in workstring. Made gauge ring run to 1750' and SION.

3/25/2020 Set CIBP at 1735'. Tagged with workstring and circulated MLF. Tested casing to 600#. Casing good. Spot 50 sx Class C cement on top of CIBP. POOH to 418' and circulated cement to surface inside 5 1/2" casing with 50 sx cement. Rig down. Dug out and cut off wellhead. Filled up both strings of casing with less than 1 sack of cement. Installed marker, removed anchors, and cleaned the pit.
