6/23/2020: Drill 12.25 inch intermediate hole to 3030 ft.

6/24/2020: Run 9.625 inch 40 lb J-55 intermediate casing to 3018 ft. Pump 40 bbls chem wash gel spacer, followed by 628 sks of 13.5 ppg lead cmt, 298 sks of 14.8 ppg tail cmt. Drop plug and displace with 226 bbls of fresh water. 15 bbls of cmt return to surface. Test casing to 1500 PSI for 30 minutes, good test.

6/24/2020: Drill 8.75 inch second intermediate hole to 9260 ft.

6/27/2020: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 9250 ft. Pump 20 bbls chem wash, 20 bbls water, followed by 556 sks of 11.5 lead cmt, 130 sks of 13.2 ppg tail cmt. Drop plug and displace with 422 bbls of cut brine. 5 bbls spacer returned to surface. Est TOC at 1842 ft. Test casing to 2100 PSI for 30 minutes, good test.
