7/3/2020: Retest Surface casing as previous test failed. Test for 30 minutes 1500 psi, good test.

7/3/2020: Drill 12.25 inch first intermediate hole to 3035 ft.

7/4/2020: Run 9.625 40 lb J-55 first intermediate casing to 3024 ft. Pump 20 bbls chem wash and 20 bbls visc water, followed by 791 sks of 13.5 ppg lead cmt, 298 sks of 14.8 ppg tail cmt. Drop plug and displace with 227 bbls freshwater. 85 bbls cmt returned to surface. Test casing to 1500 psi for 30 minutes, good test.

7/5/2020: Drill 8.75 inch second intermediate hole to 9590 ft.

7/7/2020: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 9574 ft. Pump 20 bbls chem wash and 20 bbls visc water, followed by 572 sks of 11.5 ppg of lead cmt, 146 sks of 13.2 ppg tail cmt. Drop plug and displace with 437 bbls of cut brine. 10 bbls of spacer returned to surface. Est
