8/3/2020: Drill 17.5 inch hole surface 390 ft. Run 13.375 inch 54.5 lb J-55 surface casing to 376 ft. Pump 60 bbls gel spacer, followed by 505 sks of 14.8 lead cmt. Drop plug and displace with 48 bbls of brine. 62 bbls of cmt returned to surface. Test casing to 1500 psi for 30 minutes, good test.

Surface Casing Details: Casing ran: 8/3/2020, Fluid Type Fresh Water, Hole 17.5 inch, Csg Size 13.375 inch, Weight 54.5 lbs, Grade J55, Est TOC 0 ft, Depth set 376 ft, Cement 505 sacks, Yield 1.35, Class C, Pressure Held 1500 psi, Pres Drop 0.
