# Surface Use Plan

### Burton 6 Federal No. 3

- 1. Existing Roads: Area maps, Exhibit "A" shows the proposed well site as staked. Exhibit "B" is a reproduction of Eddy Co. General Highway Map. Exhibit "C" is a reproduction of a USGS Topographic Map, and Exhibit "C-1" is a well site layout map, showing proposed road to location and existing road to nearest county road.
  - A. The maximum width of the driving surface will be 15.' The road will be crowned and ditched with a 2% slope from the tip of the crown to the edge of the driving surface. The driving surface will be made of 6" rolled and compacted caliche. The lead-off ditches will be 1' deep with 1% minimum to 3% maximum slopes to drain water. Ditches will be placed according to BLM formula for lead-off ditch intervals. A minimum 18" tin-horn will be placed under the reconstructed road at the small draw as shown on Exhibit C-1.
  - B. From the junction of Hwy 360 and Curry Comb Rd, turn West on Curry Comb Rd for 4.8 miles. Turn South on existing lease road 1.5 miles. Turn East for 0.8 miles, then South for 0.3 miles, then East for 0.5 miles to proposed lease road.

## 2. Planned Access Roads:

241.9' of on-lease access road will be built.

### 3. Planned Powerlines:

A 3-phase, 3-wire, 300' span power line with 63 40' poles built to BLM Raptor specs. Line will follow access road from the Burton 6 Fed #3 to the Burton 6 Fed #1 well pad. RECEIVED ARTESIA

## 5. Location of proposed construction Facilities:

If on completion this well is a producer, 4" SDR-7 poly pipe will be laid along proposed new and reconstructed lease road from the #3 well to the #1 tank battery to carry oil, gas, and water to the #1 tank battery. See production facilities layout diagram. Any changes to the facilities or off-site facilities will be accompanied by a sundry notice.

### 6. Location and Type of Water Supply:

Water will be purchased locally from a commercial source and trucked over the access roads.

#### 7. Source of Construction Material:

If possible, native caliche will be obtained from the excavation of drill site. Topsoil will be pushed back from the drill site and existing caliche will be ripped and compacted. Then topsoil will be stockpiled on location as depicted on Exhibit "D" (rig layout). If additional material is needed, it will be purchased from a BLM-approved pit as near as possible to the well

## 8. Methods of Handling Waste Material:

- A. Drill cuttings will be seperated by a series of solids removal equipment and stored in steel containment pits and then hauled to a state-approved disposal facility.
- B. All trash, junk and other waste material will be contained in trash cages or bins to prevent scattering. When the job is completed all contents will be removed and disposed of in an approved sanitary land fill.
- C. Salts remaining after completion of well will be picked up by supplier including broken sacks.
- D. Sewage from living quarters will drain into holding tanks and be cleaned out periodically and hauled to a waste disposal facility. A Porta-John will be provided for the rig crews. This equipment will be properly maintained during the drilling operations and removed upon completion of the well.
- E. Drilling fluids will be contained in steel pits in a closed circulating system. Fluids will be cleaned and reused. Water produced during testing will be contained in the steel pits and disposed of at a state approved disposal facility. Any oil or condensate produced will be stored in test tanks until sold and hauled from the site.

## 9. Ancillary Facilities:

A. No camps or airstrips to be constructed.

### 10. Well Site Layout:

- A. Exhibit "D" shows location and rig layout.
- B. Mud pits in the closed circulating system will be steel pits and the cuttings will be stored in steel containment pits.
- C. Cuttings will be stored in steel pits until they are hauled to a state-approved disposal facility.
- D. If the well is a producer, those areas of the location not essential to production facilities will be reclaimed and seeded per BLM requirements.

### 11. Plans for Restoration of Surface:

Rehabilitation of the location will start in a timely manner after all drilling operations cease. The type of reclamation will depend on whether the well is a producer or a dry hole.

Drainage systems, if any, will be reshaped to the original configuration with provisions made to alleviate erosion. These may need to be modified in certain circumstances to prevent inundation of the location's pad and surface facilities. After the area has been shaped and contoured, topsoil from the spoil pile will be placed over the disturbed area to the extent possible. Revegetation procedures will comply with BLM standards.

If the well is a dry hole, the pad and road area will be recountoured to match the existing terrain. Topsoil will be spread to the extent possible. Revegetation will comply with BLM standards.

Should the well be a producer, those areas of the location not essential toproduction facilities and operations will be reclaimed and seeded per BLM requirements. Please see Production Facilities Layout Diagram, exhibit D-1.

### 12. Other Information

- A. Topography consists of a sloping plane with loose tan sands. Vegetation is mainly yucca, mesquite and shin oak.
- B. The wellsite is on surface owned by Department of the Interior, Bureau of Land Management. The land is used mainly for farming, cattle ranching, recreational use, and oil and gas production.
- C. In lieu of an archaeological survey report, Cimarex will be submitting an MOA application for this well pad and access road since they are within the MOA boundary.
- D. There are no know dwellings within 1½ miles of this location.






