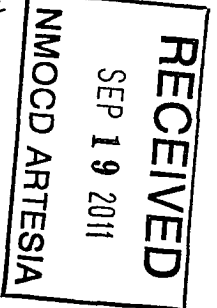

On 6/21/06 landed 2-7/8" 6.5# J-55 tbg @ 3481'. Ran pump & rods. Released completion rig on 6/22/06. Completed as a single Glorieta-Yeso oil well.
