Spudded well on 8/22/11. Drilled 12-1/4" hole to 450'. Set 8-5/8" 24# J-55 csg @ 434'. Cmted lead w/150 sx (200 cf) "C" cmt w/2% Cacl2, 1/4# cello flake & tail w/200 sx (264 cf) "C" cmt w/2% Cacl2. Circ 118 sx cmt to pit. On 8/24/11, pressure tested 8-5/8" csg to 1500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3674' on 8/30/11 & set 5-1/2" 17# J-55 production csg @ 3658'. Cmted w/lead 350 sx (662 cf) 65/35 poz "C" cmt w/5# salt, & 1/8# cello flake & tailed w/300 sx (399 cf) cl "C" cmt w/1/8# cello-flake & 2% Cacl2. Circ 107 sx cmt to pit. Released drilling rig on 8/31/11. Plan to pressure test 5-1/2" csg before completion operations.
