2. Solids and contaminated fluid will be hauled to the approved facility as required.

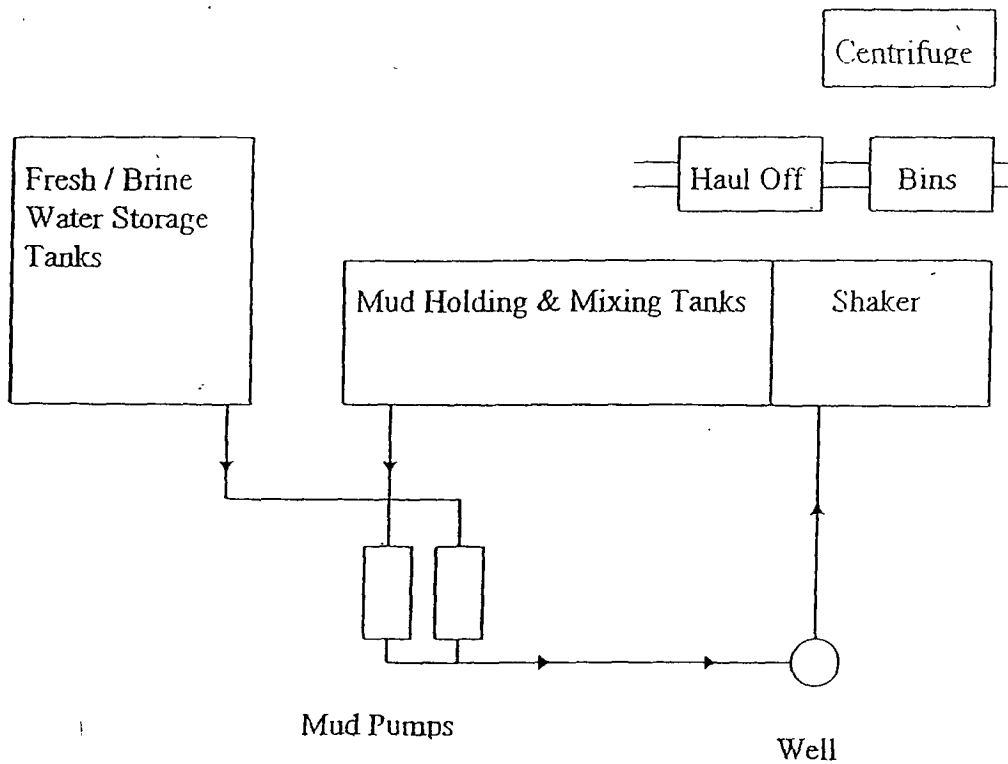
