- 4) MIX X PUMP A 25 SX. CMT. PLUG @ 5,355'-5,155' (T/B.S.); WOC X TAG TOP OF CMT. PLUG.
- 5) MIX X PUMP A 25 SX. CMT. PLUG @ 2,622'-2,422' (9-5/8" CSG. SHOE).
- 6) PERF. X ATTEMPT TO SQZ. A 50 SX. CMT. PLUG @ 1,775'-1,665' (T/DLWR.); WOC X TAG TOP OF CMT. PLUG.
- 7) PERF. X ATTEMPT TO SQZ. A 50 SX. CMT. PLUG @ 1,525'-1,410' (B/SALT); WOC X TAG TOP OF CMT. PLUG.
- 8) PERF. X ATTEMPT TO CIRC. TO SURF. A 110 SX. CMT. PLUG @ 268'-3'.
- 9) DIG OUT X CUT OFF WELLHEAD 3' B.G.L.; WELD ON STEEL PLATE TO CASINGS X INSTALL DRY HOLE MARKER.
