All leaks should be kept to less than 5 barrels. Rig crews will monitor the tanks at all times.

with cellar in center of pad

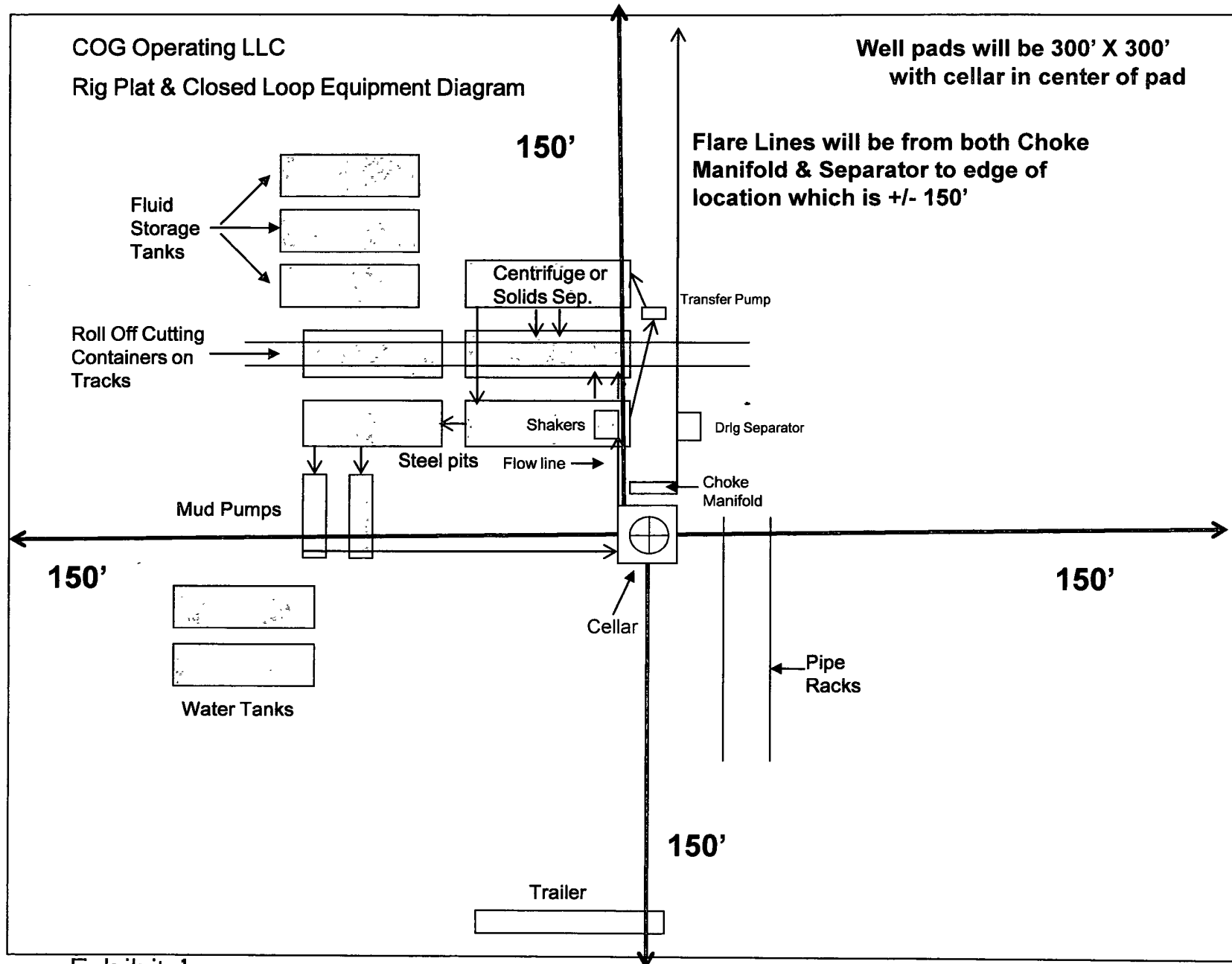
