Cmted lead w/175 sx (231 cf) "C" cmt w/2% Cacl2 & 1/4# cello flake & tail w/200 sx (264 cf) "C" cmt w/2% Cacl2. Circ 85 sx cmt to pit. On 11/16/11, pressure tested 8-5/8" csg to 1500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD4538' on 11/21/11. On 11/21/11, set 5-1/2" 17# J-55 production csg @ 4522'. Cmted lead w/295 sx (534 cf) 35/65 poz "C" cmt w/5% salt, 5# LCM-1, 0.25% FL-52, & 1/8# cello flake & tailed w/480 sx (653 cf) cl "C" cmt w/1% FL-25, 1% BA-58, 0.4% SMS, 5% salt, 3# LCM-1, & 1/8# cello-flake. Circ 102 sx cmt to surface. Released drilling rig on 11/22/11. Plan to pressure test 5-1/2" csg before completion operations.
