Dear Operator;

Under the provisions of Rule 19.15.9.705 the following applies to your Lea C Lease in Eddy County, NM located at Sec 11 - 17S - 31E:

C. Abandonment of Injection Operations

(1) Whenever there is a continuous one year period of non-injection into any injection project, storage project, salt water disposal well, or special purpose injection well, such project or well shall be considered abandoned, and the authority for injection shall automatically terminate ipso facto.

In that these wells may not be used for injection purposes, it is requested you reclassify them and notify this office in writing (Form C-103) of the reclassification.

All of these wells have authorized Temporary Abandon Status until 2007 except the Lea C #11. It is requested you make arrangements to perform a casing integrity test on this well and notify this office in writing (Form C-103) of your intended use for the well. It is also required that you notify this office 24 hours in advance of the casing integrity test, so we may witness if at all possible.
