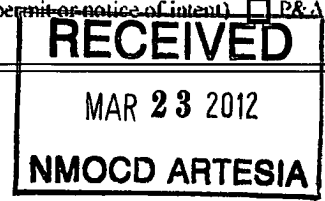

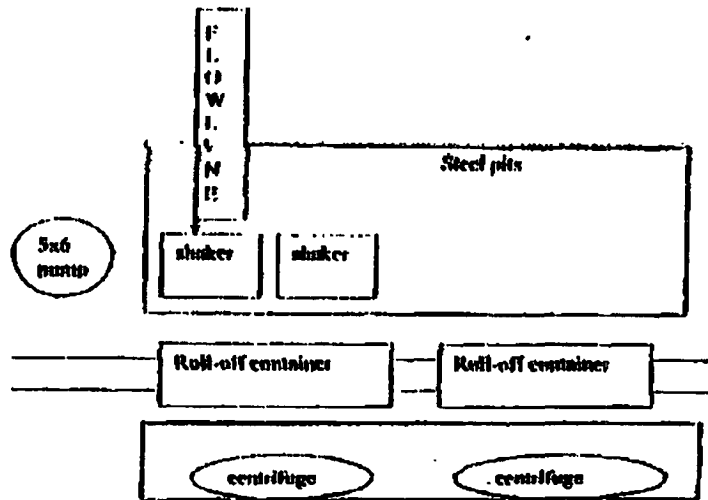
Any leak in system will be repaired and or/contained immediately
