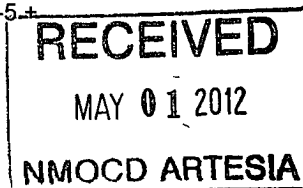

4/8/12 - TD 17-1/2" hole to 370'. Set 13-3/8" 48# J-55 ST&C casing at 370'. Cemented with 440 sx Class "C" + 0.25#/sx Cellophane Flakes + 2% CaCl (yld 1.35, wt 14.8). Circulated 212 sx to 1/2 round. Tested casing to 1200 psi for 30 min. WOC 35 hrs. Reduced hole to 12-1/4" and resumed drilling.

4/16/12 - TD 12-1/4" hole to 3301'. Set 9-5/8" 36#, 40# K-55 LT&C casing at 3301'. Cemented with 600 sx Class "C" + 4% Bentonite + 0.125#/sx Cellophane Flake + 0.1% FL52 + 5#/sx LCM-1 + 5% MPA-5 + 1% Sodium Metasilicate + 5% Sodium Chloride (yld 2.13, wt 12.5). Tailed in with 200 sx Class "C" (yld 1.33, wt 14.8). Cement did not circulate. Ran temp survey. TOC at 250'. Ran 1" pipe to cement. Tagged cement at 249'. Cemented with 130 sx Class "C" + 2% CaCl (yld 1.32, wt 14.8). Circulated 65 sx to roll off pin. Tested casing to 1500 psi. WOC. Reduced hole and resumed drilling.
