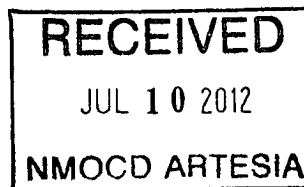
To lay a 4" surface SWD line from the CDU #89H is located 250 FSL, 1980 FEL of Section 3, T25S-R31E, then east 14.60 feet to a surveyed trunk line located in the NW/4NE/4 of said section.

The spacing for said line will be 30 feet wide by 14.60 feet (0.88 rods), consisting of 0.010 acres.

The line will carry approximately 300 bwpd at 100 psi.

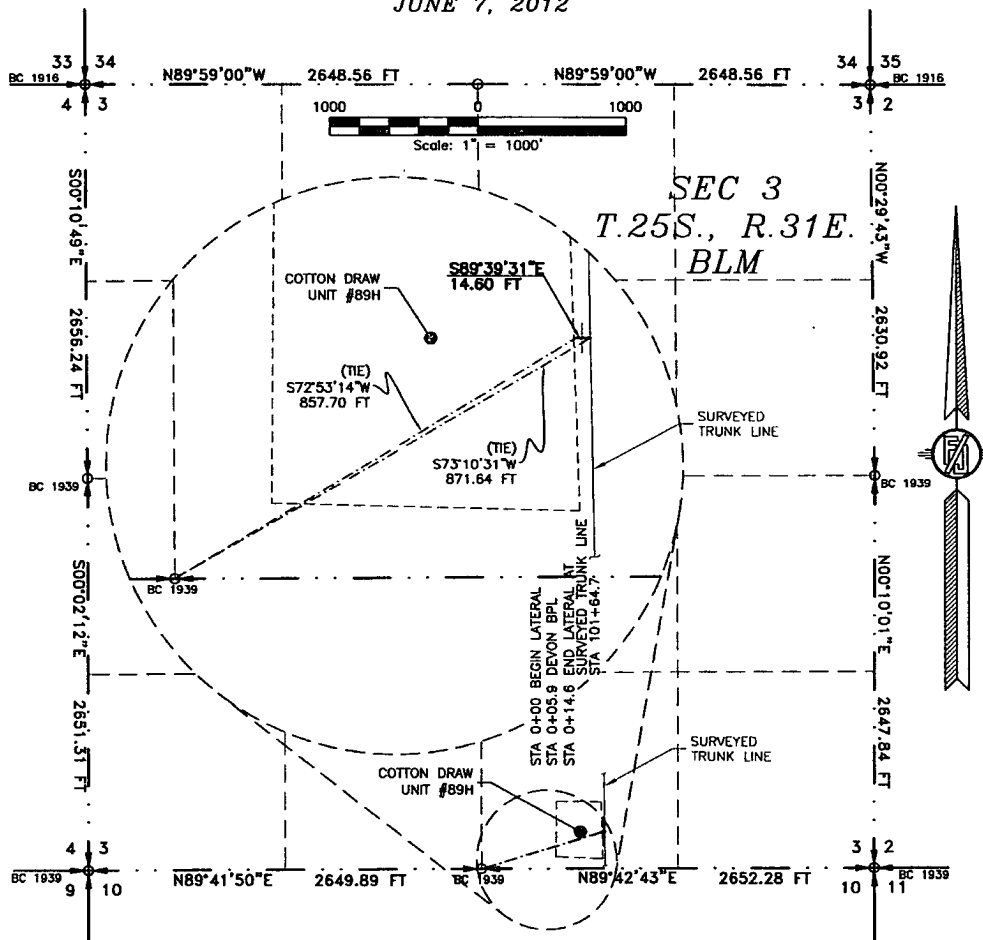

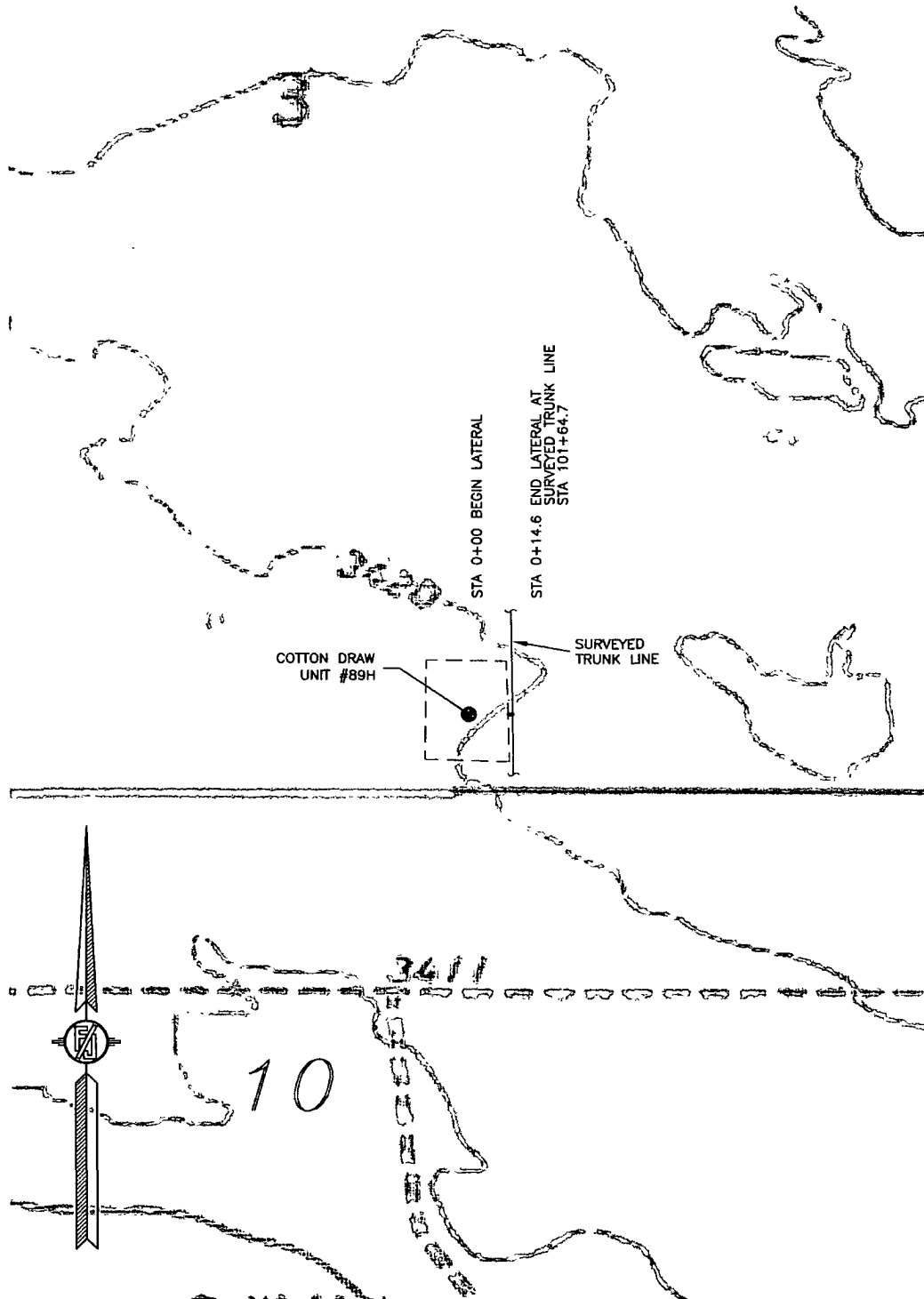
