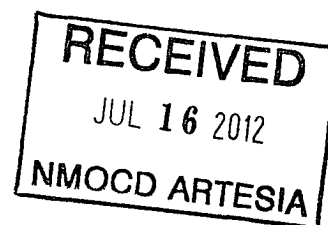

Tail: 200 sx of "C" + .2% PF13 (retarder) mixed at 14.8 ppg (1.33 cf/sk)

Final cement volume will be determined from fluid caliper
