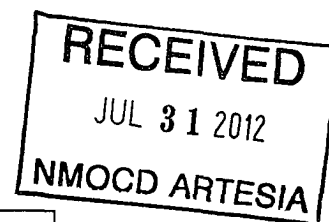

Circulated 92 sx to pit. WOC 19 hrs 30 min. Tested casing to 1200 psi, held good. Reduced hole to 7-7/8" and resumed drilling.
