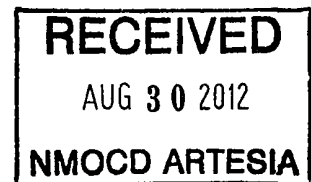

LRE OPERATING, LLC would like to change the BOP from the 3 ram BOP on the approved APD to a 2 ram 5M BOP. See attached 2 ram 5M BOP diagram. We were unable to find a 3 ram BOP to replace the 2 ram 5M BOP on the UDI drilling rig #45. The rig spudded this well on 8/23/12 and is currently drilling a 12-1/4" hole for intermediate 9-5/8" csg. We plan to use the 2 ram 5M BOP when drilling out of the 9-5/8" csg shoe.

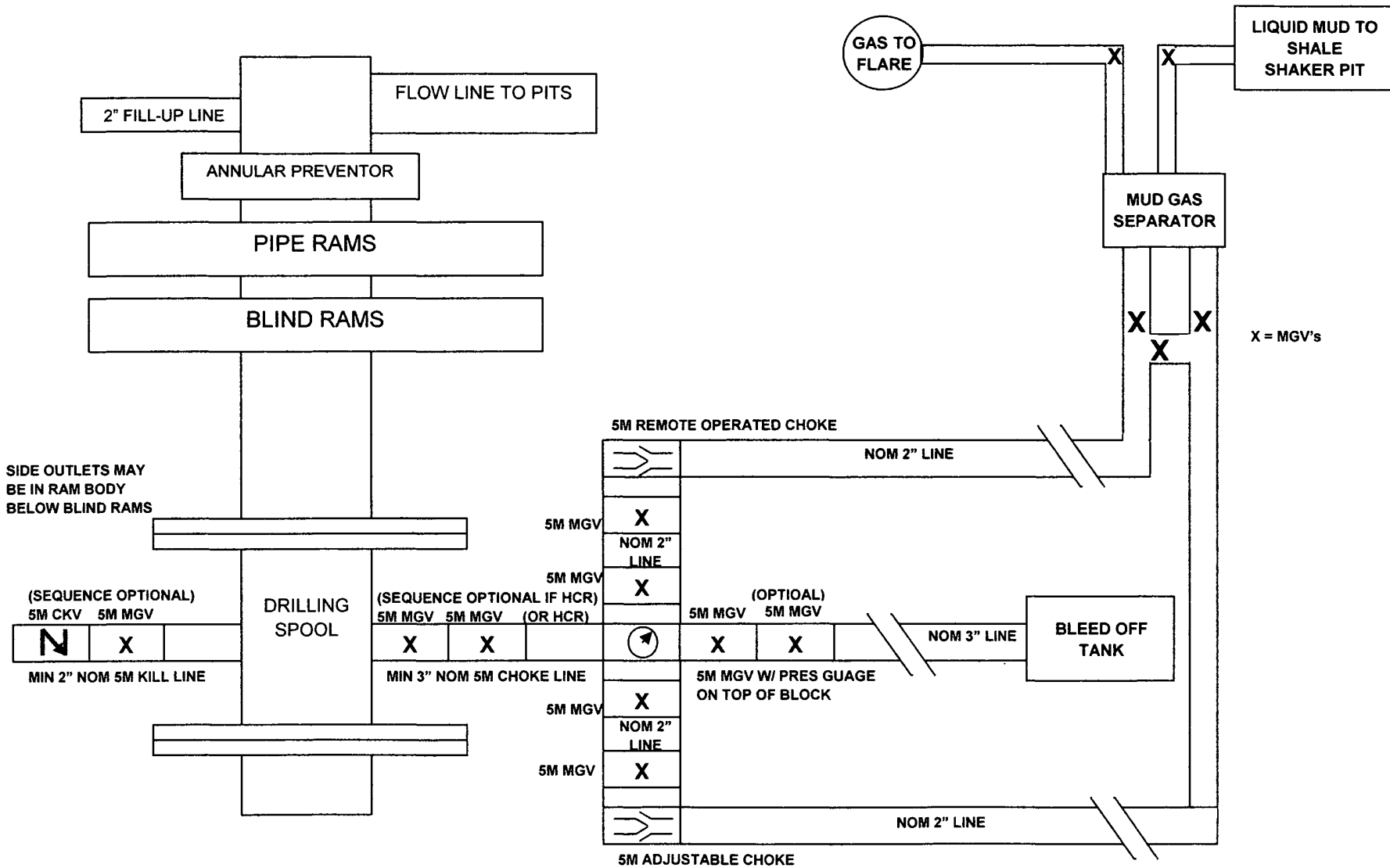
