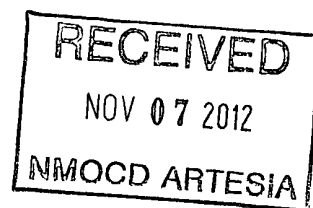

The proposed plan is to install 3-4" polyethylene lines on the surface to transport oil, gas and water from the Goodnight 27 #5 to the Goodnight 27 #1 as laid out on the attached survey plat. The lines will be located in Section 27, T-23-S, R-29-E, Eddy County, New Mexico. Construction should begin within 30 days of BLM approval.

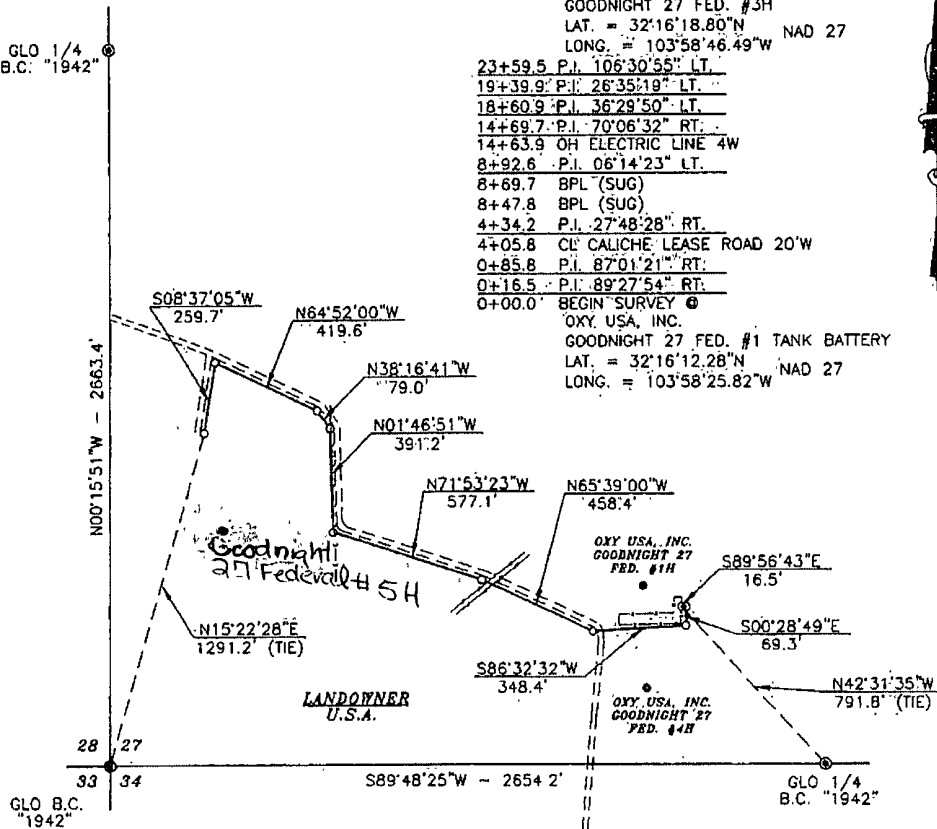
