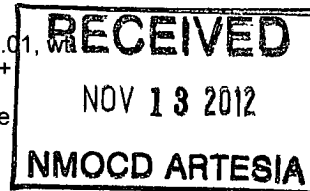

Cemented with 900 sx 35:65:6 Poz "C" + 0.1% D013 + 0.3% D112 + 0.125#/sx D130 + 7% D022 + 5#/sx D042 + 5% D044 + 0.2% D046 (yld 2.01, wt 12.8). Tailed in with 360 sx 50/50 Poz "C" + 0.125#/sx D130 + 3#/sx D042 + 5% D044 + 0.2% D046 + 0.2% D065 (yld 1.36, wt 14.2). Circulated 307 sx to pit. Tested casing to 1500 psi for 30 min.

10/11/12 - Test casing start 1493 psi down to 1400 psi in 30 min. WOC 40 hrs 30 min. Reduced hole to 8-3/4" and resumed drilling.
