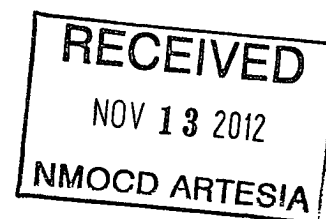

10/3/12 - Tested casing to 1200 psi for 30 min with no appreciable leak off. WOC 38 hrs 10 min.

Reduced hole to 12-1/4" and resumed drilling.
