Comments on Inspection:

Fresh oil at wellhead and on casing. Tank battery north of well has fresh oil at truck loading point which is running down to road. Flow line running east of tank battery leaking at clamped repair point. Remediation required. Packing on wellhead and clamp on flow line need to be repaired to eliminate leaking. All oil at wellhead, flowline leak and tank battery need to be removed and hauled away. Contact NMOC District 2 Environmental Compliance Officer to discuss remediation requirements.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
