- 5/24/05 Found casing to be bad from 1956' down to 2208'. Tested good below and above this spot. Found 2 holes, 1 at 2154' and 1 at 2102'. Ran CBL from 3000' up to 1100', estimated TOC 1600'.
- 5/26/05 Set 5-1/2" cement retainer at 1792'. Squeezed holes in casing 1952'-2207' with 100 sx "C" Neat and 50 sx with 2% Cal-Seal. Pumped 100 sx cement into formation. Squeezed off at 2000 psi. Drilled out retainer. Drilled cement from 1795' to 1922'. Tested casing to 2000 psi every connection.
- 6/1/05 Drilled cement from 1922'-2205'. Fell out of cement at 2205'. Tested 5-1/2" casing to 2000 psi. Held good.
- 6/3/05 Perforate Abo 2843'-2849' (7), 2852'-2866' (15), 2880'-2886' (7), 2892'-2904' (13), 2928'-2938' (11), 2958'-2962' (5), 2972'-2986' (15), 3012'-3016' (5) and 3082'-3094' (13).
- 6/6/05 Acidize Abo with 2250g 7-1/2% IC acid and 137 balls.
- 6/9/05 Frac Abo with 42,000g Waterfrac 30 and 150K 16/30 Brady. Perforate Abo 2578'-2594', 2606'-2612' 2618'-2630', 2648'-2650', 2654'-2664', 2670'-2674', 2680'-2684' and 2706'-2724' for a total of 80 holes. Frac with 42,000g WF-30 and 150K 16/30 Brady. 2-3/8" tubing and SN at 2500'.
